REGULATIONS INTERMEDIATE ATTESTATION OF STUDENTS AT THE DEPARTMENT OF BIOLOGY OF MEDICAL

Designed based on recommendations for intermediate certification of students training in higher education programs using electronic teaching aids and distance learning technologies at the Crimean Federal University named after V.I. Vernadsky

- 1. Interim certification is carried out in the form of an exam.
- 2. The exam is held on dates set by the training department and deans.
- 3. Intermediate certification at the Department of Medical Biology is carried out in two stages:
- 3.1. The first stage of the intermediate certification is carried out simultaneously, for all examinees, in the form of testing strictly on the established date and time, with a time limit for the assignment.
- 3.1.1. Testing platform Moodle, the identity of the examiner is carried out by entering the examiner into your personal account with the login and password.
- 3.1.2. The number of test tasks is 100. In each question, the examiner gives 1 answer out of 5 possible. Testing time is 100 minutes.

3.1.3. Criteria for evaluating test results:

3.2.1 Students with an average score in the discipline of **4.7 or more and scientific work** (performance at the student society, conferences, published abstracts, article, completed all tasks of the Challenge (1st in one of the nominations)),

with an average score in the discipline less 4.7 points, but higher than 4.0 and those who took 1st place at the conference are exempted from passing the intermediate certification with the mark "EXCELLENT".

Students who have an average grade in the discipline of **less than 4.7 points**, **but higher than 4.0** and **scientific work** (speaking at the student society, conferences, published abstracts, articles, and all tasks of the challenge) are exempted from passing the intermediate certification with a rating of "GOOD"

- 3.2.2. Students who have an average score of **4.3-4.6** and who have **received a rating of 5 or 4 based on the test results** are given an intermediate assessment rating of "EXCELLENT" or "GOOD", respectively.
- 3.2.3. Students who have an average score of **3.8-4.2** and who have **received a rating of 5 or 4 based on the test results** are given a grade of intermediate

certification of "GOOD".

- 3.2.4. Students who have an average score of **3.0-3.7** and who have **received a rating of 5 on the results of testing** are given an assessment of intermediate certification "GOOD".
- 3.2.5. Students who have an average score of **3.0-3.7** and who have **received a grade of 4 or 3 based on the test results** are given a grade of intermediate certification "SATISFACTORY".
- 3.2.6. Students who do **not fall** into the above categories are given a grade corresponding to the test results.
- 3.3. The second stage of intermediate certification is carried out for students who have an average score of less than 3.0 and successfully completed the 1st stage of intermediate certification (who received a rating of "SATISFACTORY" and higher).
- 3.3.1. The second stage of intermediate certification is carried out in the form of a student's oral answer to the questions of the exam ticket in **Skype video** conferencing systems, with video and audio recording of the student's answer with saving the video file of the oral answer.
- 3.3.2. The student establishes a video link with the examiner at the set date and time. **The identification of the student** during the oral examination is carried out on the basis of an identity document (**passport**, **student card**, **test book**).
- 3.3.3. Each student is required to overview, using a webcam, to show the room in which he is located, for the absence of unauthorized persons, as well as reference and information materials not provided for in the test program. During the preparation and response to the exam ticket, the student is obliged to demonstrate the screen of his laptop / smartphone, through which video communication is carried out (by means of the "screen sharing" function). Before the exam begins, the student will be informed about the period of time allocated for preparing the answer on the exam ticket (15 minutes).
- 3.3.4. The exam is conducted on **examination tickets**. The ticket selection procedure is performed using the random number generator program online https://generator-online.com/numbers/.
- 3.3.5. During the exam, the student has **no right to use technical means**, **reference books**, **tables and other reference literature**.
- 3.3.6. If during the passing or passing the exam on the part of the student there were violations of the discipline (cheating, use of mobile communications, PCs,

other technical devices), an attempt was made to forge documents, the teacher has the right not to take into account the results of the student's response with a rating of "UNSATISFACTORY" in the statement.

- 3.3.8. If there is no **Internet connection** on the day of the exam and it is impossible to present the results of intermediate certification, the student is obliged to inform the employee of the dean's office and / or the head teacher of the department by telephone.
- 4. A student who has **not passed the intermediate certification** due to illness or other valid reasons, documented (to the dean's email address), by order of the dean in electronic form, the session dates may be extended. A medical certificate or other document must be submitted by e-mail to the dean's office within 3 business days after recovery or termination of the factors that entailed the omission of interim certification activities.
- 5. Upon receipt of an unsatisfactory mark for the exam, the student has the opportunity of another 2 attempts of intermediate certification (with test results of 49% or less, which corresponds to an unsatisfactory mark). Dates and dates of additional retakes are determined by the academic department of the academy.
